When the Collection Box was circulated, it realised a sum of £13.15.6 which was donated to the Newbury Masonic Hall Building Fund in appreciation of the kindness of the Management Committee in making the Temple available to the Hungerford Chapter for the Consecration Ceremony.

Rísings

Nothing was offered from Supreme Grand Chapter.

On the Second and Third Rising, Comp. Scribe E announced that Provincial Grand Chapter would meet under the banner of Abbey Chapter No: 945 at Abingdon on June 4th 1965.

On the Fourth Rising E. Comp. J. proposed and E. Comp H seconded a vote of thanks to the Chair for their services at the ceremony, and to those two Companions from Winchester who had so kindly assisted Comp. Bancroft in making some of the furniture for the Chapter.

The Chapter was closed in due form and with solemn prayer at 5.30pm.
